

Short title and Commencement	1. (I) These rules may be called the Himachal Pradesh Rural Development Department, Block Development Officer, Class-I (Gazetted) Recruitment and Promotion (First Amendment) Rules, 2016.  (II) These rules shall come in to force from the date of publication in Rajpatra, Himachal Pradesh.
